

Minutes of 11/07/2023 General Committee Meeting 8 p.m. via Zoom

The meeting met the requirements for being quorate.

1.0 Welcome and Apologies

Apologies noted.

2.0 Approval of Minutes

Agreed: Minutes of the General Committee meeting on 13th June 2023 were approved. [AGR 230711 2.0.1]

3.0 Club Vision and Development Plan Update

Following last month's decision on introduction of a Junior rate, the Committee considered the impact on, and fee base calculation for, the category of Family Membership.

A number of options were assessed and points looked at including if a Junior progresses from Flatwater to Whitewater. As the £5 fee is to remove barriers to entry it will stay for the year, even if the individual progresses to whitewater activities. Only in the new Membership Year will the higher Whitewater fee (currently £40) be payable.

MD recommended we look at Club Membership from a different perspective so that standard Club Membership, whether Individual or Family, gives access to Flatwater, and then, Whitewater participation is an add-on to that. By extension, the Junior category as agreed last meeting should equally apply to adults. Again, this would give greater access and expansion. Funding and sponsorship for access activities and participants can be obtained, and therefore Club Membership can expand further and be more inclusive.

PN suggested we can get Open Days and Taster sessions going to build interest; and, PP suggested we also need to think about longer standing members who are no longer attending due to financial considerations. It was agreed to discuss this separately and look at membership options to accommodate welfare needs at a future meeting.

Scenarios and options were also discussed if Flatwater participants want to engage in development on Whitewater. Current practice was confirmed that this would be through specific courses and coaching, and only with appropriate arrangements made and suitable funding and or fees from participants or third parties. JH emphasised the absolute need of ensuring no safety issues arise from non-assessed members trying to use Whitewater.



In discussing coaching costs and charges for FW, PP recommended there be a nominal charge to ensure interest and commitment but where possible, search for subsidies and funding to offset the costs.

Agreed: Club Membership (Flatwater access only) agreed at £5 + £10, and
